## PRIVACY POLICY

This privacy policy applies between you, the User of this Website, and AG Motor Works Ltd, the owner and provider of this Website. ## **Definitions and interpretation**

Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;
GDPR	the UK General Data Protection Regulation;
AG Motor Works Ltd , we or us	AG Motor Works Ltd, a company incorporated in England and Wales with registered number 14623856 whose registered office is at 40 Mill Farm Avenue, TW16 7DG;
User or you	any third party that accesses the Website and is not either (i) employed by AG Motor Works Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to AG Motor Works Ltd and accessing the Website in connection with the provision of such services; and

- 2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

- 3. This privacy policy applies only to the actions of AG Motor Works Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

## Data that is given to us by you

in each case, in accordance with this privacy policy.

## Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:

#### Our use of Data

## Your rights

- 16. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."   - b. **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
  - c. **Right to erase** the right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
  - e. Right to data portability the right to request that we move, copy or transfer your Data.
  - f. **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.

- 24. You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonably believe your rights will not be affected.
- 25. If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
- 26. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 27. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
